Ubego Privacy Policy

This Personal Data Privacy Policy (hereinafter referred to as Privacy Policy) applies to all information posted on Ubego, as well as in relation to information that Ubego users indicate while using Ubego, its services, programs and products and transferred to the owner of Ubego Individual entrepreneur Konstantin Evgenievich Frumkin (OGRNIP 317784700164122; INN: 784001354673 (hereinafter referred to as the Owner of Ubego).

Ubego is the commercial designation of individual entrepreneur Konstantin Evgenievich Frumkin. Ubego is a Quest Platform that includes yourself Ubego website (available on the Internet at the network address https://ubego.ru/, as well as on all its subdomains) and the application.

Use of Ubego and Ubego services constitutes unconditional consent User with this Privacy Policy (both in general and in part) and the conditions for processing his personal information specified therein information; in case of disagreement with these conditions, the User must refrain from using Ubego services and leave all services Ubego.

For the purposes of this Privacy Policy, under the User Ubego is understood as a Ubego visitor who contacts the Ubego Owner by communication channels indicated on Ubego or using the services, Ubego programs and/or products.

1. General Provisions

- 1.1. Within the framework of this Policy, under personal information The User understands:
- 1.1.1. Personal information that the User provides about himself independently during registration (creating an account in your Personal Account) or in the process of contacting the Ubego Owner through the communication channels indicated on Ubego or in the process of using services, programs and/or products Ubego, including the User's personal data, including, but not exclusively, last name, first name, patronymic, place of work, position, education, age, residence addresses, email address, phone number.
- 1.1.2. Data that is automatically transmitted to Ubego services and/or To the owner of Ubego in the process of using them using installed on the software User's device, including IP address, cookie data, information about the User's browser (or other program through which services are accessed), technical characteristics of equipment and software, used by the User, date and time of access to services, addresses requested pages and other similar information. Ubego
- 1.1.3. Other information about the User that the User voluntarily provides in the process of using Ubego and/or contacting the Owner Ubego via communication channels indicated on Ubego.
- 1.1.4. This Privacy Policy applies only to Ubego. The owner of Ubego does not control and is not responsible for the Ubego of third parties persons to whom the User can follow links available on Ubego.

2. Purposes of processing personal information of users

2.1. Ubego and/or the Ubego Owner collects and stores only that personal information that is necessary to provide services or execution of agreements and contracts with the User, as well as information necessary for carrying out advertising campaigns by the Owner of Ubego, for

except in cases where legislation provides for mandatory storage of personal information for a period specified by law. Ubego uses only necessary information about the User.

- 2.2. Personal information of the Ubego User and/or the Ubego Owner processes for the following purposes:
- 2.2.1. Identification of the User who contacted the Ubego Owner, using Ubego services and/or registered on Ubego, for making transactions of a civil nature with the Owner of Ubego.
- 2.2.2. Providing the User with access to personalized Ubego resources.
- 2.2.3. Establishment by the Owner of Ubego with the User of feedback, including sending notifications, requests regarding the use Ubego and sending information about goods/services/works indicated on Ubego to the User's email address, processing requests and applications from the User, as well as making calls to a phone number The user for the purpose of making transactions of a civil nature.
- 2.2.4. Sending information and other materials to the User.
- 2.2.5. Improving the quality of Ubego services and functions for providing the user with better services.
- 2.2.6. Development of new services and functions that may be useful To the user.
- 2.2.7. Confirmation of the accuracy and completeness of personal data, provided by the User.
- 2.2.8. Notifying the Ubego User about changes in the operation of Ubego or Owner of Ubego, or change of Ubego domain name.
- 2.2.9. Providing the User with effective client and technical support if you encounter problems using Ubego.
- 2.2.10. Carrying out advertising activities in relation to goods/works/services of the owner of Ubego with the consent of the User.
- 2.2.11. Conducting statistical and other research.
- 2.2.12. Execution of the User Agreement.

3. Conditions for processing personal information of users and its transfer to third parties Ubego

- 3.1. The owner of Ubego and/or Ubego stores personal information Users in accordance with internal regulations adopted by Owner of Ubego.
- 3.2. In relation to the User's personal information, it is retained confidentiality, except in cases of voluntary provision User information about himself for unlimited public access circle of people.
- 3.3. Ubego and/or the Ubego Owner has the right to transfer personal information User to third parties in the following cases:
- 3.3.1. The user expressed consent to such actions by performing transactions with the Ubego Owner or otherwise.
- 3.3.2. The transfer is necessary for the performance of a specific agreement or agreement with the User.
- 3.3.3. The transfer is provided for by Russian legislation within the framework procedure established by law. Ubego has the right to transfer information if it follows from the requirements of the current legislation of the Russian Federation.
- 3.3.4. In the event of a sale of Ubego by the Owner of Ubego, the all obligations to comply with the terms of this Policy in relation to the personal information received by him.

- 3.4. The processing of the User's personal data is carried out without limiting the term by any legal means, including in information personal data systems using automation tools or without the use of such means. Processing of personal data Users are provided in accordance with the Federal Law of 07.27.2006 N 152-FZ "On personal data".
- 3.5. In case of loss or disclosure of personal data, the Owner of Ubego informs the User about the loss or disclosure of personal data.
- 3.6. The owner of Ubego takes the necessary organizational and technical measures to protect the User's personal information from unauthorized or accidental access, destruction, alteration, blocking, copying, distribution, as well as from other unlawful actions of third parties.
- 3.7. The Ubego Owner, together with the User, accepts all necessary measures to prevent losses or other negative consequences, caused by the loss or disclosure of the User's personal data.
- 3.8. Any personal information is provided by the User voluntarily.
- 3.9. Personal information provided by the User is reliable until proven otherwise.
- 3.10. The user bears full responsibility for the accuracy provided personal information, including on issues related to the legal capacity of the User.
- 3.11. The user is aware of all the negative consequences of providing invalid or irrelevant information.
- 3.12. Any User understands and agrees that part the information posted by him may be available to Ubego Users Privacy settings can be changed in the Movie Card settings. Ubego

4. Obligations of the parties

- 4.1. The user is obliged:
- 4.1.1. Provide information about personal data necessary for use of Ubego and for the performance of a specific agreement or contract with the owner of Ubego.
- 4.1.2. Update and supplement the information provided about personal data if this information changes.
- 4.1.3. The user has the right to withdraw his consent to processing personal data by sending a notice of revocation to the Ubego Owner by email inquire@ubego.ru.
- 4.2. The owner of Ubego is obliged to:
- 4.2.1. Use the information received solely for the purposes specified in this Privacy Policy.
- 4.2.2. Ensure that confidential information is kept confidential and not disclose without the prior written permission of the User, and also not to sell, exchange, publish or disclose other possible ways of transmitting personal data User, except as provided for in this Policy privacy.
- 4.2.3. Take precautions to protect privacy personal data of the User in accordance with the procedure usually used to protect this type of information in existing business transactions.
- 4.2.4. Block personal data related to to the relevant User, from the moment of contact or request The user, or his legal representative or authorized body to protect the rights of personal data subjects during the verification period in the event identifying false personal data or illegal actions.

5. Responsibility of the parties

- 5.1. The owner of Ubego who has not fulfilled his obligations shall be liable liability for losses incurred by the User in connection with unlawful use of personal data, in accordance with legislation of the Russian Federation.
- 5.2. In case of loss or disclosure of confidential information The owner of Ubego is not responsible if this confidential information:
- 5.2.1. Became public domain before its loss or disclosure.
- 5.2.2. Was received from a third party before it was received Owned by Ubego.
- 5.2.3. Was disclosed with the consent of the User.

6. Dispute resolution

- 6.1. Before filing a claim in court for disputes arising from the relationship between Ubego User and Ubego Owner are required to filing a claim (written proposal for voluntary dispute resolution). Ubego
- 6.2. The recipient of the claim within 30 (thirty) calendar days from the date receipt of the claim notifies the claimant in writing about results of consideration of the claim.
- 6.3. If no agreement is reached, the dispute will be referred to the court. in accordance with the current legislation of the Russian Federation.
- 6.4. To this Privacy Policy and the relationship between The User and the Owner of Ubego apply the current legislation of the Russian Federation.

7. Additional terms

- 7.1. The owner of Ubego has the right to make changes to this Policy confidentiality without the consent of the User indicating the date of validity new edition.
- 7.2. The new Privacy Policy comes into force from the moment it is posting on Ubego, unless otherwise provided by the new edition of the Policy privacy.
- 7.3. Provided by the User when making payments on Ubego personal information is confidential and is not subject to disclosure. Bank card data is transmitted only encrypted form and are not saved on Ubego.
